- 6.3 Vice President 2 (Purn): schedule sent to PCAHA; awaiting game numbers; all ATOM managers have requested the game numbers and still haven't heard
- 6.4 Vice President 3 (Ron): Photo Retakes this Thursday at 6pm in QP arena 6.5 Treasurer (Chuck):
- 6.5.1 Balance sheet: distributed a balance sheet up to today for costs incurred up to the end of January. It looks like we will end up about \$25000 in the hole this year but this was expected because we attributed more funds to development this year

- 6.7 Coach Coordinator (Pete): coaches' feedback has been sent to RPM to have them prepare a report for us; RPM schedule was supposed to end March 15, so we will cut it off on March 8th when the banner games are on March 10th; coach evaluation letter went out received 133 already and they come for coaches at all level; would like to send out a letter soon regarding applications for rep coaches; 2 H2 coaches completed their hybrid certification
- 6.8 Referee in Chief (Mirko): Kids doing well; a couple of issues with coaches; some issues with absences due to illness
- 6.9 Equipment Manager (Kevin W.): will re-jig jersey sets to 17 and 2; started looking at alternate suppliers
- 6.10 Ice Allocator (Lynda): everything is regular to March 8^{th} ; we need to know which teams will be using their ice March $9^{th}/10^{th}$ weekend; then we need to decide what to do from March $10\text{-}15^{th}$.
